**SUMMARY OF TAX EXEMPTION PROGRAMS - FY2018**

A tax exemption is a release from the obligation to pay all or a portion of a tax. Applications should be filed with the Board of Assessors every fall. The deadline for filing an application is three months to the day after the third quarter actual bills are mailed. The deadline is usually during the end of March. **Ownership: Applicant must own and occupy the property as of July 1, 2017**
