Green Zone (In-Person Learning)

- H+W 7-day incidence rate is less than < 4 per 100,000
- Adjoining Towns 7-day incidence rate is less than <4 per 100,000
- Very Good to Excellent Compliance, 91-100% with safety strategies



If any one of the measures in the Green Zone are not met, consider other relevant metrics including percent positivity rates/trends and local hospital case numbers/trends in the consideration of a move to the Yellow Zone

Yellow Zone (Hybrid Learning)

- H+W 7-day incidence rate is 4-8 per 100,000
- Adjoining Towns 7-day incidence rate is 4-8 per 100,000
- Good to Very Good Compliance, 75-90% with safety strategies



If any one of the measures in the Yellow Zone are not met, consider other relevant metrics including percent positivity rates/trends and local hospital case numbers/trends in the consideration of a move to the Red Zone

Red Zone (Remote Learning)

- H+W 7-day incidence rate is greater than > 8 per 100,000
- Adjoining Towns 7-day incidence rate is greater than > 8 per 100,000
- Poor to Good Compliance, less than < 75% with safety strategies

*If all measures are met, HWRSD may remain in current Color Zone (Effective 10/5/2020)

Red Zone (Remote Learning)

- H+W 14-day incidence rate is greater than > 8 per 100,000
- Adjoining Towns 14-day incidence rate is greater than > 8 per 100,000



Consider a move to Yellow Zone when all 3 YELLOW Measures are met for a minimum period of 14 days with other relevant metrics including percent positivity rates/trends and local hospital case numbers/trends.

Yellow Zone (Hybrid Learning)

- H+W 14-day incidence rate is 4-8 per 100,000
- Adjoining Towns 14-day incidence rate is 4-8 per 100,000
- Assumed Compliance is Good to Very Good, 75-90% with safety strategies



Consider a Move to Green Zone when all 3 GREEN Measures are met for a minimum of 14 days with other relevant metrics including percent positivity rates/trends and local hospital case numbers/trends.

Green Zone (In-Person Learning)

- H+W 14-day incidence rate is less than < 4 per 100,000
- Adjoining Towns 7-day incidence rate is less than <4 per 100,000
- Very Good to Excellent Compliance, 91-100% with safety strategies

*If any of the Zone Measures are met, consider staying in the Current Zone (Effective 10/5/2020)
