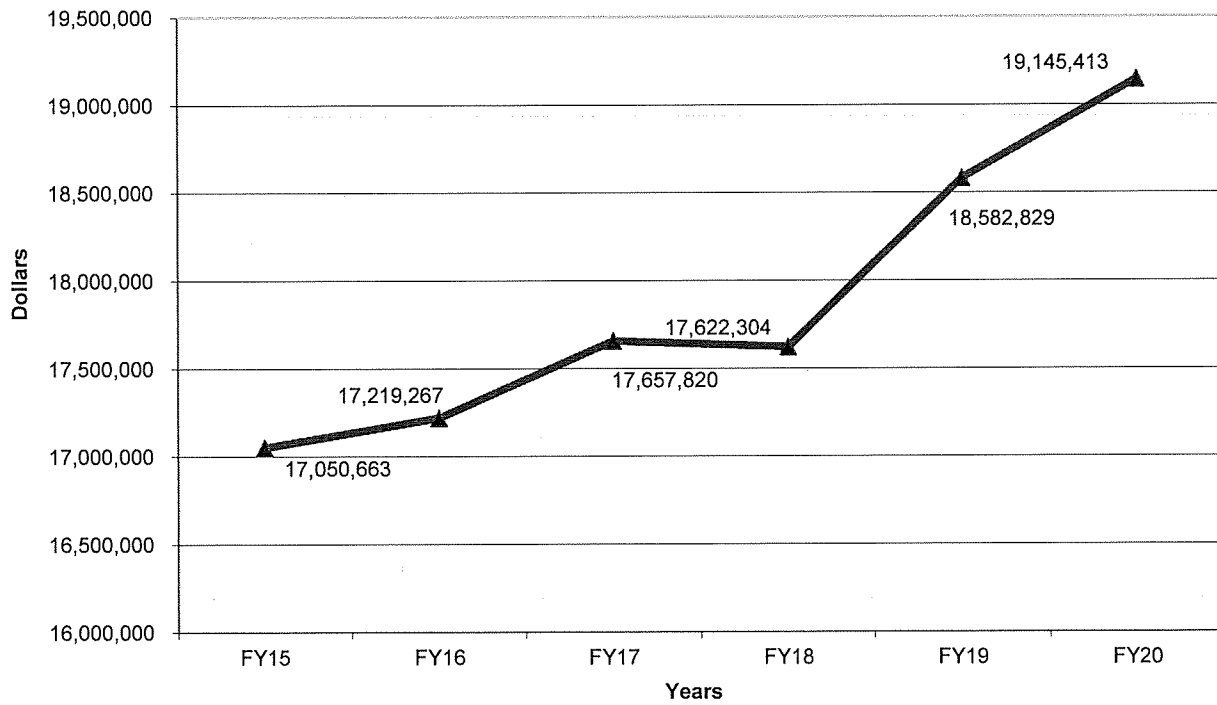

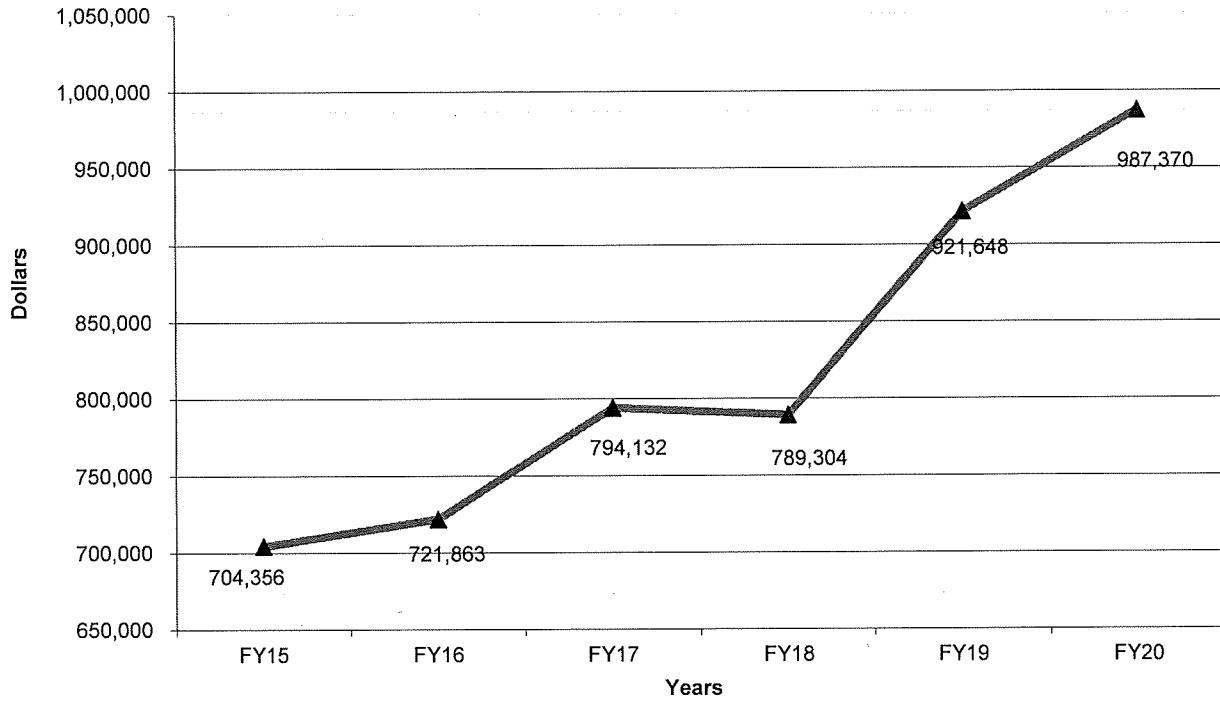
Education Costs

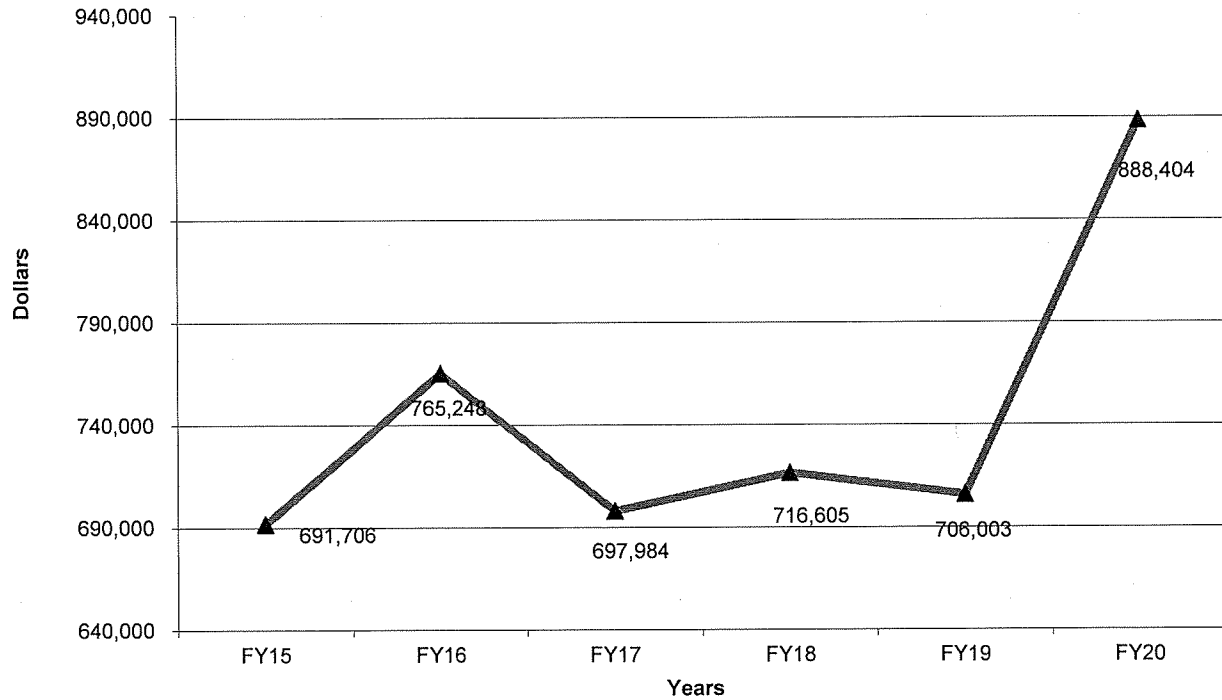
Retirement Costs
