Ed Howard opened the meeting at 6:06 p.m. He welcomed new member Olivia Hyde to the Commission.

DISCUSSION OF RFP FOR CONSULTANT TO PREPARE HISTORIC DISTRICT DESIGN GUIDELINES

The Commission reviewed the draft RFP for consultants to prepare the design guidelines for the historic district. The Commission made several changes, including putting a date on the document, changing the date the RFP was due and changing a reference to the review committee to the Commission. These changes will be incorporated into the document.

Dorr Fox also presented a list of consultants that he had obtained from the Preservation Massachusetts Consultants Directory. He had noted the consultants who stated they specialized in preservation planning or design guidelines for historic districts. The Commission members selected several consultants to send the RFP to. These consultants included Eric Dray, Essex Preservation Consulting, Finegold Alexander & Associates, Wendy Frontiero, Katy Holmes, PAL, Arnold Robinson and Stacey Spies.

Scott Clements made a motion to approve the document with amendments. Katherine Mittelbusher seconded the motion and it was unanimously approved.

Mr. Clements made a motion to send the RFP to the list of consultants that they had determined would be the best consultants to prepare the document. Jack Hauck seconded the motion and it was unanimously approved. Ms. Mittelbusher noted that they should send it out so that other consultants may also be able to respond. Mr. Fox stated that he would look into whether it could be placed on the historic preservation listsery.

CELL TOWER PROJECT AT 577 BAY ROAD

Mr. Howard noted that Varsity Wireless, the company which plans to build the cell tower behind Town Hall, has contacted Mr. Fox so that they can appear before the Historic District Commission. It was also mentioned by Mr. Howard that Varsity Wireless has won a court decision and that the decision is being contested by the Planning Board. Mr. Fox stated that he had told them that they can appear before the Commission following the completion of all appeals, and if the appeals are resolved in Varsity's favor.
