RE: Bridge Street – Scenic Road Public Hearing – Tree Removal

The Town of Hamilton Department of Public Works is planning a road improvement project for portions of Bridge Street (between Bay Road and Miles River Road) and Miles River Road. The proposed work includes drainage improvements and improvements to sidewalks. Additionally, several existing trees within the right-of-way are proposed to be preserved. However the work also includes the removal of two trees on Bridge Street in proximity to the Miles River crossing on the north side of the road to accommodate proposed drainage facilities. Due to the proximity of the proposed work to a wetland (Miles River), the improvements require approval of the Conservation Commission, an application of which is currently pending.

Bridge Street is a designated Scenic Road under M.G.L. Ch. 40 S. 15C (see attached statutory language). Staff was not able to locate a Scenic Road bylaw specific to Hamilton so the statutory language should guide the Planning Board review. The proposed road improvement plans, a narrative from the Town's engineering consultant, public hearing/notice information, photos, and associated materials are provided for the Board's review.

Part I ADMINISTRATION OF THE GOVERNMENT

Title VII CITIES, TOWNS AND DISTRICTS

Chapter 40 POWERS AND DUTIES OF CITIES AND TOWNS

Section 15C SCENIC ROAD DESIGNATIONS; IMPROVEMENTS; FINES

Section 15C. Upon recommendation or request of the planning board, conservation commission or historical commission of any city or town, such city or town may designate any road in said city or town, other than a numbered route or state highway as a scenic road; provided, however, that a numbered route may be designated by a city or town as a scenic road if its entire length is contained within the boundaries of said city or town, and no part of said route is owned or maintained by the commonwealth.

After a road has been designated as a scenic road any repair, maintenance, reconstruction, or paving work done with respect thereto shall not involve or include the cutting or removal of trees, or the tearing down or destruction of stone walls, or portions thereof, except with the prior written consent of the planning board, or if there is no planning board, the selectmen of a town, or the city council of a city, after a public hearing duly advertised twice in a newspaper of general circulation in the area, as to time, date, place and purpose, the last publication to occur at least seven days prior to such hearing; provided, however, that when a

public hearing must be held under the provisions of this section and under section three of chapter eighty-seven prior to the cutting or removal of a tree, such hearings shall be consolidated into a single public hearing before the tree warden and the planning board, or if there is no planning board, the selectmen of a town, or the city council of a city, and notice of such consolidated public hearing shall be given by the tree warden or his deputy as provided in said section three of chapter eighty-seven. Any city or town making said scenic road designation may make an ordinance or by-law establishing that a violation of this paragraph shall be punished by a fine not to exceed three hundred dollars.

Designation of a road as a scenic road shall not affect the eligibility of a city or town to receive construction or reconstruction aid for such road pursuant to the provisions of chapter ninety.

Mark Connors Planning Director During her campaign, Bowen also brought up environmental responsibility in relation to both housing and the health of the Ipswich River watershed.



Bowen holds a bachelor's degree in political science from Yale, and a master's in public administration from Harvard's Kennedy School. She has worked in Californian local government and the U.S. Peace Corps in Ghana. In the nonprofit sector, she has worked on global health policy, sustainable investing, conflict resolution, and other aims.

Bowen said the conversations she had with voters during the campaign will stay with her as she begins work on Beacon Hill.

"Since the beginning, this campaign was always about meeting residents where they're at and listening to their questions and concerns," Bowen said. "I feel a deep responsibility to take that energy and translate it into effective advocacy for Beverly and Wenham."
