

**SOLICITATION FOR QUOTES  
MODEL T BUILDING MATERIALS

The Town of Hamilton in conformance with Massachusetts General Law Ch. 30, Section 39M is soliciting for quotes for construction materials related to the Hamilton Model T building, located at 265 Bay Road, Hamilton, MA 01982. Each supplier is to review the building plan set and submit a complete material listing for all the building structural components, i.e. the wood framing, fasteners, seals, insulation, roofing materials, trim and molding, etc. Concrete materials are not included. Identified material quantities are estimates and the Town reserves the right to increase or decrease as necessary.

All quotes are due no later than **4:30p.m. on Wednesday, August 27<sup>th</sup>, 2025** by email at [tolson@hamiltonma.gov](mailto:tolson@hamiltonma.gov).

All bidders must supply the Town with an insurance certificate and workmen's compensation policy, if applicable.

All bidders must abide by all contract terms associated with the attached contract. All bidders must sign Attachment B and C with their quote.

Bids must be submitted on the Solicitation of Quotes Form included as an attachment to this document. Please feel free to contact me at 978-626-5227 if you have any questions or comments concerning this issue.

The bidder agrees that its quote shall be good and may not be withdrawn for a period of 30 days, Saturdays, Sundays, and legal holidays excluded, after the opening of the bids.

The Town will reject quotes when required to do so by the above referenced General Laws. The Town reserves the right to waive any informality, to accept or reject, in whole or in part any or all quotes, or take whatever other action may be deemed to be in the best interest of the Town.

Attention is directed to the minimum wage rates to be paid as determined by the Commissioner of Labor and Workforce Development and the weekly payroll record submittal requirements under the provisions of Massachusetts General Laws, Chapter 149, Section 26 through 27D inclusive.

The bidder agrees that its bid shall be good and may not be withdrawn for a period of 30 days, Saturdays, Sundays, and legal holidays excluded, after the opening of the bids.

The Town reserves the right to waive any informalities, to accept or reject, in whole or in part any or all bids, or take whatever other action may be deemed to be in the best interest of the Town.
